## **South pole**

Major player in the carbonoffsetting industry, focusing on developing projects to sell carbon credits.

Projects: tree planting in Africa, renewable energy in China.

Expanded rapidly, opening branches in various countries and attracting major investments and billion-dollar valuation.

### THELAKE KARIBA PROJECT

In an area facing economic instability, deforestation, and high unemployment, South Pole started a project offering training in sustainable agriculture and buying carbon credits based on protected trees that went uncut as a result of the new sustainable habits. Then, South Pole was selling those carbon credits to companies who were aiming to achieve carbon neutrality.

The project covered two million acres of forest in North-Western Zimbabwe





### \* HOW DID SOUT POLE OPERATE?

1 Metric Ton of Co2 = 1 Carbon Credit

DOD ONEHUNDRED DO ALARS

Carbon Credits are created and bought based on a calculation where avoided deforestation creates credits. South Pole buys the credits at a low price from the developer of the project who pledges to invest most profit into the project



South Pole sells the credits (with a commission) to companies who are looking to be carbon neutral.

## WHAT WAS ACTUALLY HAPPENING?

Steve Wentzel, the project developer, said that most of the money would go into the project, but in reality the community saw little money of the profits that Wentzel and South Pole were making. Although some progress was made in the Lake Kariba project with new schools, clinics, anti-poaching patrols, there are reports that Wentzel was buying gold mines, horseriding ranges and investing in other business of dubious origin.

Elmon Mudenda, a local community leader, said in 2014 that nothing tangible was happening, and in 2015 two researchers found that the natural resources of the area were actually up for the taking, and not being protected as promised by South Pole.



# WHAT WAS ACTUALLY HAPPENING?

Using NASA satellite imagery environmental data analysts found that the deforestation was actually a lot lower than South Pole initially reported, meaning that approximately 27 million carbon credits of the 52 million created were based on false data.

These credits were sold to companies who then could advertise their products as "Carbon Neutral".

South Pole reportedly made €100 million from the Lake Kariba project alone, with a profit margin of at least 50%.





### WHAT WERE THE CONSEQUENCES?

The unearthing of this scandal by several news sources damaged the reputation of South Pole and raised questions about the legitimacy of all their other projects, and the carbon offsetting industry as a whole.

Many South Pole employees resigned and South Pole lost a vast amount of their market share, leading to the crash of carbon credits on the market and the eventual closing of the Lake Kariba project.

Because of South Pole, the European Parliament proposed banning the "Net-Neutrality" claim if based only on offsetting projects.

### CARBON OFFSETTING: DESTROYOR REFORM?

Are all Carbon Offsetting companies operating like South Pole? Are all Carbon Neutral claims false? Initiatives like the Naturefriends Climate Fund, VCMI (Voluntary Carbon Markets Integrity initiative) or Sylvera aim to guarantee the integrity of this approach.
